

Privacy notice on exercising data subjects' rights in connection with processing photos and video recordings taken at events

To exercise your rights, you may contact the data protection officer of the **Hungarian Catholic Bishops' Conference** (seat: 1071 Budapest, Városligeti fasor 45., tax number: 18181490-1-42, „HCBC”) at the email address adatvedelem@katolikus.hu.

HCBC complies with your request on exercising your data subjects' rights within a maximum of one month from the receipt thereof. The date of receipt of the request does not count for the calculation of the deadline. If necessary, taking into account the complexity of the request and the number of requests, HCBC may extend this deadline by another two months. HCBC notifies you of the extension of the deadline, stating the reasons for the delay, within one month of receiving the request.

You may exercise the following rights in connection with the processing of your personal data:

1 Withdrawal of consent

You have the right to withdraw your consent given to the processing of your personal data at any time in person, by post or by electronic mail.

2 Right to access

You have the right to receive information from HCBC regarding whether HCBC processes your personal data, and you can request a copy of the processed personal data.

If HCBC processes your personal data, then you are entitled to get to know

- (i) what personal data does HCBC process, on what legal basis, for what data processing purpose, and for how long,
- (ii) to whom, when, on the basis of which law, which of your personal data did HCBC provide access to or to whom did it transfer your personal data,
- (iii) the source of your personal data,
- (iv) whether HCBC uses automated decision-making and its logic, including profiling.

Upon your request, HCBC provides you with a copy of the personal data subject to data processing for the first time free of charge, after which it may charge a reasonable fee based on administrative costs.

In order to meet the data security requirements and protect your rights, HCBC must make sure that the identity of the data subject and you match, for this purpose the information, access to the data, and the issuance of a copy of the data are also subject to the identification of the data subject.

3 Right to restriction of the data processing

You may request that HCBC restricts the processing of your personal data if

- (i) you contest the accuracy of the personal data (in this case HCBC restricts the data processing so long as it verifies the accuracy of the personal data),
- (ii) the processing is unlawful and you oppose the erasure of the personal data and request the restriction of their use instead,
- (iii) HCBC no longer needs the personal data for the purpose of the processing, but you require the restriction of the personal data for the establishment, exercise or defence of legal claims or

- (iv) you objected to the processing (in this case the restriction is for so long as it is established whether the legitimate reasons of HCBC take precedence over the legitimate reasons of the data subject).

4 Right to object

In the case of data processing based on legitimate interests, you may object to data processing if, in your opinion, HCBC does not process your personal data properly in connection with the purpose specified in this privacy notice. In this case HCBC shall prove that the processing of personal data is justified by compelling legitimate reasons that take precedence over the interests, rights and freedoms of the data subject, or that are related to the submission, enforcement or defense of legal claims.

5 Right to erasure

You may ask HCBC to erase your personal data. Upon request, HCBC deletes your personal data without undue delay if (i) HCBC does not need the personal data for the purpose for which the personal data were collected or processed, (ii) you object to data processing and HCBC has no preceding legal reasons for the data processing, (iii) HCBC processed your personal data unlawfully or (iv) HCBC is obliged to delete the personal data in order to fulfill its legal obligations.

If HCBC has made the personal data public and is obliged to delete them, it will do everything that is expected of it in order to inform the personal data processors that you have requested them to delete the links to the given personal data or the copy or duplicate of the personal data.
